DY8 Chart-Based/EHR Measures Due March 31

Completed DY8 Standard Reporting Workbooks (SRW) and Measure Validation Templates (MVT) must be uploaded to the [SFTP](#) by **March 31, 2020**. Timely submission of these documents is critical to ensuring timely payment to participating hospitals.

As a reminder the following resources are available for use in hospital's submissions:

DY8 Standard Reporting Workbooks (SRWs) and Measure Validation Templates (MVTs) were uploaded to each hospital's inbound [SFTP](#) folder on Wednesday, January 15, 2020. Please use these latest versions of the documents when submitting DY8 data.

DY8 attribution rosters were uploaded to hospital and reporting partner inbound [SFTP](#) folders on January 31, 2020. Please use these attribution rosters when calculating your DY8 Chart Based/EHR Measures.

Databook 6.0 was posted on the [Resources](#) page of the New Jersey DSRIP website on Wednesday, January 15, 2020. A clean version and a redlined version are available so that changes can be easily found. This update contains small revisions to three Chart Based/EHR Measures which are identified in the revision log. Databook 6.0 should be used when calculating DY8 Chart Based/EHR Measures.

Please contact the NJ DSRIP team if you need help accessing your SFTP account or encounter any other technical difficulties related to the SFTP. **Please be sure to test your access to the NJ DSRIP SFTP before the submission deadline!** The process to reset credentials on an SFTP account can take up to **five business days**, so it is essential that you bring any SFTP access issues to our attention as soon as possible.

Now Available: DY8 SA2 Progress Report Materials

The Demonstration Year 8 Semi-Annual 2 (DY8SA2) Progress Report materials were posted to the NJ DSRIP [Participants](#) webpage of the NJ DSRIP website on February 19th. Progress Reports are due from participating NJ DSRIP hospitals by **April 30, 2020**. Hospitals will be required to complete and submit the DY8SA2 Progress Report Template, Budget Template, and appropriate documentation to the [NJ DSRIP SFTP](#).

Hospitals should review the DY8SA2 Progress Report Guidance Document before completing the DY8SA2 Progress Report Template and Budget Template. As a reminder, all hospitals are required to use the provided templates when completing the progress report.

Updated: NJ DSRIP Dashboard

The [NJ DSRIP Dashboard](#) has been refreshed for DY7 and DY8. DY7 data now reflects fully adjudicated, post-appeals results. As a reminder, annual DY7 data includes MMIS claims from January 1, 2018 to December 31, 2018.

DY8 Quarter 3 data has also been uploaded to the dashboard and is now available to view. The DY8 Quarter 3 data (abbreviated as DY8Q3) includes MMIS claims from June 30, 2019 through September 30, 2019 and was calculated using the DY7 attribution.
