[DY8 Resources for Chart-Based/EHR Measures](#)

New: DY8 attribution rosters were uploaded to hospital and reporting partner inbound [SFTP](#) folders on January 31, 2020. A notification was sent to hospitals and reporting partners when the rosters were made available. Please use these attribution rosters when calculating your DY8 Chart Based/EHR Measures.

Databook 6.0 was posted on the [Resources](#) page of the New Jersey DSRIP website on Wednesday, January 15, 2020. A clean version and a redlined version are available so that changes can be easily found. This update contains small revisions to three Chart Based/EHR Measures which are identified in the revision log. Databook 6.0 should be used when calculating DY8 Chart Based/EHR Measures.

DY8 Standard Reporting Workbooks (SRWs) and Measure Validation Templates (MVTs) were uploaded to each hospital's inbound [SFTP](#) folder on Wednesday, January 15, 2020. Please use these latest versions of the documents when submitting DY8 data. Completed SRW and MVT must be uploaded to the [SFTP](#) by **March 31, 2020**.

Please contact the NJ DSRIP team if you need help accessing your SFTP account or encounter any other technical difficulties related to the SFTP. **Please be sure to test your access to the NJ DSRIP SFTP before the submission deadline!** The process to reset credentials on an SFTP account can take up to **five business days**, so it is essential that you bring any SFTP access issues to our attention as soon as possible.

Updated: The NJ DSRIP Dashboard

The [NJ DSRIP Dashboard](#) has been updated! The Dashboard now includes a Stage 1 page for System Transformation Measures. Filters and selections on this page are similar to those on the rest of the Dashboard.

Pre-appeals DY7 annual data is now available on the Dashboard. When the DY7 appeals process concludes, the Dashboard data will be updated to reflect appeals determinations. The DY7Q4 data on the Dashboard includes all MMIS claims from 2018 (January 1, 2018 – December 31, 2018).

Unadjudicated DY8 Q1 and Q2 data (displayed as DY8Q2) has also been uploaded to the Dashboard. DY8Q2 data includes MMIS claims from January 1, 2019 through June 30, 2019. The DY8Q2 measures were calculated using DY7 attribution and the performance results are based on claims data from the first 6 months of the DY8 measurement year. All DY8 "AV Earned" values will be listed as 0, until annual DY8 data is available in the Dashboard, as AVs are based on annual performance. Similarly, "ITG Exceeded" metrics will be listed as 0 for the semiannual data.
