DY8 Reporting Extension

- CMS approved an extension for remaining DY8 reporting.
- The following materials are now due on June 30th, 2020:
 - Standard Reporting Workbooks (SRW);
 - Measure Validation Templates (MVT); and
 - DY8 Semi-Annual 2 Progress Reports.
- Materials will be accepted on a rolling basis until the June 30th deadline.
- Submit all materials via NJ [SFTP](#) Outbound folder.

DY8 Appeals Process

DY8's new two-part payment structure will prompt two separate appeals cycles.

Appeal Cycle 1 – Post Interim Payment:

Occurs after hospitals receive their DY8 claims-based (MMIS) measure results and interim payment (estimated end of July).

Appeal Cycle 2 - Prior to Final Payment:

Occurs after hospitals receive their DY8 non-claims-based (chart-based) measure results, prior to the final payment.

All appeals adjustments will be reconciled in the DY8 final payment.
